## **BFRC Smarts Sub Licence Scheme - Application Guidance £560 per Annum**

### **Key steps to becoming a BFRC Sub Licences;**

- 1) Complete the form below attached to join this BFRC Approved scheme this allows you to cascade Smart Systems BFRC licenses.
- 2) If you are going to distribute unglazed frames, you will need to know the performance specification of the sealed unit in order to generate a licence.

**Sealed units performance needs to be identical to the  
BFRC Window Energy Rating Declaration, performances cannot be substituted.**

Each different sealed unit performance must be individually simulated in the WER software.  
Using the actual centre pane, thermal transmittance and spacer bar used.

- 3) Send your completed application form along with payment to:  
BFRC Ltd, 54 Ayres St, London, SE1 1EU.
- 4) Upon acceptance of your application, Smarts energy rated products will be listed alongside your company details on the BFRC website. You will also be issued by a unique BFRC registration number which can be included on your simulation from the WER software.
- 5) As a BFRC Authorized Sub License, you will be required to retain documentary evidence relating to the purchase and supply BFRC rated products – With sealed units you will need to keep a record of what specification of glass has been purchased and from whom.
- 6) BFRC and Smart Systems reserve the right to carry out on site inspections you will be required to make available all relevant documentation regarding the WER declaration. BFRC and Smart Systems reserve the right to remove membership.
- 7) The WER software tool remain property of Smart Architectural Aluminium.

**Profile must be purchase through Smart Architectural Aluminium  
Sealed units must be manufactured in accordance with BS EN 1279 pt 5.  
3rd party test evidence / certification or a CE marking declaration will be required from the IGU  
manufacturer. – You will be asked to provide this when you are audited**

**Licence holders supplying unglazed product, then the license holder must ensure that the  
company providing the glass understands and meets the performance specification simulated.  
Purchase orders, delivery notes for IGU's will be required during the audit**
